WHO celebrates 75th anniversary and calls for health equity in face of unprecedented threats

Director-General calls on governments and leaders to take action to protect and invest in health and care workers who are at the forefront of the response to health and climate emergencies

3 April 2023 News release

On 7 April 2023, the World Health Organization (WHO) will mark its 75th anniversary, along with its 194 Member States and other partners, by calling for a renewed drive for health equity.

Seventy-five years ago, in the aftermath of the deadliest and most destructive war in human history, the <u>Constitution of the World Health Organization</u> came into force: a treaty between the nations of the world, who recognized that health was not only a fundamental human right, but also fundamental to peace and security.

Over the past seven and a half decades, there has been extraordinary progress in protecting people from diseases and destruction, including smallpox eradication, reducing the incidence of polio by 99%, saving millions of lives through childhood immunization, declines in maternal mortality and improving health and well-being for millions more.

"The history of WHO demonstrates what is possible when nations come together for a common purpose," said Dr Tedros Adhanom Ghebreyesus, WHO Director-General. "We have much to be proud of, but much work to do to realize our founding vision of the highest attainable standard of health for all people. We continue to face vast inequities in access to health services, major gaps in the world's defences against health emergencies, and threats from health harming products and the climate crisis. We can only meet these global challenges with global cooperation."

To meet these challenges, WHO is urging countries to take urgent action to protect, support and expand the health workforce as a strategic priority. Investments in education, skills and decent jobs for health need to be prioritized to meet the rapidly growing demand for health and avert a projected shortage of 10 million health workers by 2030; primarily in low- and middle-income countries.

A global education programme on basic emergency care targeting 25% of nurses and midwives from 25 low- and middle-income countries by the end of 2025 was also recently announced by WHO. This 25x25x25 emergency care programme will provide nurses and midwives with the skills and competencies to make a major difference in saving lives and reducing disabilities.

Looking forward to the next 75 years and close to the turn of the next century, a renewed commitment to health equity will be the key to addressing future health challenges. In the shadow of the COVID-19 pandemic, WHO's roadmap to recovery includes an urgent paradigm shift towards promoting health and well-being and preventing disease by addressing its root causes and creating the conditions for health to thrive. WHO is urging countries to provide health by prioritizing primary health care as the foundation of universal health coverage. The COVID-19 pandemic has shown that protecting health is fundamental to our economies, societies, security and stability. Learning from the worst pandemic in recent history, WHO stands ready to support the countries of the world as they negotiate a pandemic accord, the revision of the International Health Regulations and other financial, governance and operational initiatives to prepare the world for future pandemics.

Over the past five years, WHO has invested in science and digital health, creating a Science Division led by the Organization's first Chief Scientist. This has come at a time when science is under sustained attack every day. Countries must protect the public from misinformation and disinformation. The future of health depends on how well we power health through science, research, innovation, data, digital technologies, and partnerships.

Pandemic Accord

<u>Countries set out way forward for negotiations on global agreement to protect world from</u> <u>future pandemic emergencies</u>

Countries of the World Health Organization have mapped out how negotiations on a global accord on pandemic prevention, preparedness and response will move forward with a view to presenting a draft accord for approval by the World Health Assembly in May 2024.

Ending Thursday, discussions on the draft pandemic accord took place during the fifth meeting of the <u>Intergovernmental Negotiating Body (INB</u>), which includes WHO's 194 countries.

Ms Precious Matsoso, Co-Chair of the INB Bureau, from South Africa, said: "Countries from all parts of the world were able to discuss their ideas, concerns and suggestions in a forum for all countries to hear and consider."

Countries agreed to keep a window open for additional written proposals until 22 April and that those proposals will be compiled with all others made over recent weeks into a package that will be made available to all drafting group participants.

The INB Bureau will then provide, by 22 May, in addition to this package, for consideration of the Drafting Group, a Bureau's Text, including options where feasible, based on all submissions received and included in the compilation document. The Drafting Group of the INB will then meet in June to continue negotiations.

INB Bureau Co-Chair, Mr Roland Driece of the Netherlands, said: "The world realises that what we want and need to achieve is an accord that will help us not to repeat the mistakes of the COVID-19 pandemic response. There are many proposals and constructive suggestions on the table for how to do this."

According to the process agreed by governments at a special session of the World Health Assembly in late 2021, negotiations on the draft pandemic accord will aim to produce a final draft for consideration by the 77th World Health Assembly in May 2024.

In parallel with the pandemic accord negotiations, <u>governments are also discussing</u> more than 300 amendments to the International Health Regulations (2005) (IHR) in an effort to strengthen those regulations and make the world safer from communicable diseases while ensuring greater equity in the global response to public health emergencies.

Governments have been working to ensure consistency and alignment across the INB and IHR processes. The proposed IHR amendments will also be presented to the World Health Assembly in 2024, and would together, with a future pandemic accord, provide a comprehensive, complementary, and synergistic set of global health agreements.

It is the target year to interrupt all remaining wild poliovirus type 1 (WPV1) and circulating vaccine-derived poliovirus type 2 (cVDPV2) transmission chains, per the GPEI <u>Polio Eradication Strategy 2022-2026</u>. A rigorous independent review will be undertaken by the third quarter of 2023, to assess whether the programme is on track to meeting Goal 1 and Goal 2 of the Strategy: permanently interrupt all poliovirus transmission in endemic countries; and, stop transmission of cVDPV2 and prevent outbreaks in non-endemic countries. <u>Read more</u>...

Summary

This paper is about the future role of the commercial sector in global health and health equity. The discussion is not about the overthrow of capitalism nor a full-throated embrace of corporate partnerships. No single solution can eradicate the harms from the commercial determinants of health— the business models, practices, and products of market actors that damage health equity and human and planetary health and wellbeing. But evidence shows that progressive economic models, international frameworks, government regulation, compliance mechanisms for commercial entities, regenerative business types and models that incorporate health, social, and environmental goals, and strategic civil society mobilisation together offer possibilities of systemic, transformative change, reduce those harms arising from commercial forces, and foster human and planetary wellbeing. In our view, the most basic public health question is not whether the world has the resources or will to take such actions, but whether humanity can survive if society fails to make this effort.

Abstract

When the first cases of human infection with severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) were reported from Wuhan, China, in December 2019, there was quick agreement across scientific and health communities that understanding the facts about its emergence would help prevent future outbreaks. Never could I have imagined the degree of politicization that would cloud this quest. Over the past 39 months, while reported deaths from COVID-19 increased to nearly 7 million worldwide, science on the virus's origins has gotten smaller while the politics surrounding this question has grown ever bigger. Last month, the World Health Organization (WHO) learned that scientists in China possessed data on viral samples from Wuhan that had been gathered in January 2020, which should have been shared immediately—not 3 years later—with the global research community. The lack of data disclosure is simply inexcusable. The longer it takes to understand the origins of the pandemic, the harder it becomes to answer the question, and the more unsafe the world becomes.

Achieving the IA2030 Coverage and Equity Goals through a Renewed Focus on Urban Immunization

The 2021 WHO and UNICEF Estimates of National Immunization Coverage (WUENIC) reported approximately 25 million under-vaccinated children in 2021, out of which 18 million were zero-dose children who did not receive even the first dose of a diphtheria-tetanus-pertussis-(DPT) containing vaccine. The number of zero-dose children increased by six million between 2019, the pre-pandemic year, and 2021. A total of 20 countries with the highest number of zero-dose children and home to over 75% of these children in 2021 were prioritized for this review. Several of these countries have substantial urbanization with accompanying challenges. This review paper summarizes routine immunization backsliding following the COVID-19 pandemic and predictors of coverage and identifies pro-equity strategies in urban and peri-urban settings through a systematic search of the published literature. Two databases, PubMed and Web of Science, were exhaustively searched using search terms and synonyms, resulting in 608 identified peer-reviewed papers. Based on the inclusion criteria, 15 papers were included in the final review. The inclusion criteria included papers published between March 2020 and January 2023 and references to urban settings and COVID-19 in the papers. Several studies clearly documented a backsliding of coverage in urban and peri-urban settings, with some predictors or challenges to optimum coverage as well as some pro-equity strategies deployed or recommended in these studies. This emphasizes the need to focus on context-specific routine immunization catch-up and recovery strategies to suit the peculiarities of urban areas to get countries back on track toward achieving the targets of the IA2030. While more evidence is needed around the impact of the pandemic in urban areas, utilizing tools and platforms created to support advancing the equity agenda is pivotal. We posit that a renewed focus on urban immunization is critical if we are to achieve the IA2030 targets.
