WHO invites mpox vaccine manufacturers to submit dossiers for emergency evaluation 9 August 2024 News release

WHO has today issued an <u>invitation for manufacturers of mpox vaccines to submit an Expression of</u> Interest for Emergency Use Listing (EUL).

The WHO Director-General announced on 7 August 2024 that he had **triggered the process for EUL** of mpox vaccines given worrying trends in the disease's spread. There is a serious and growing outbreak in the Democratic Republic of the Congo (DRC) that has now expanded outside the country. A new viral strain, which first emerged in September 2023, has for the first time been detected outside DRC...

WHO is requesting manufacturers to submit data to ensure that the vaccines are safe, effective, of assured quality and suitable for the target populations.

Granting of an EUL will accelerate vaccine access particularly for those lower-income countries which have not yet issued their own national regulatory approval. The EUL also enables partners including Gavi and UNICEF to procure vaccines for distribution...

There are currently two vaccines in use against the disease, both of which have been <u>recommended for</u> use by the WHO Strategic Advisory Group of Experts on Immunization, or SAGE.

WHO Director-General's opening remarks at the media briefing – 7 August 20247 August 2024

...WHO is working with the governments of the affected countries, the Africa CDC, NGOs, civil society and other partners to understand and address the drivers of these [mpox] outbreaks. Stopping transmission will require a comprehensive response, with communities at the centre.

WHO has Standing Recommendations on mpox which include advice not to impose travel restrictions on affected countries. WHO has developed a regional response plan, requiring US\$ 15 million to support surveillance, preparedness and response activities. We have released US\$ 1 million from the WHO Contingency Fund for Emergencies to support scale-up of the response, and we plan to release more in the coming days.

There are two vaccines for mpox that have been approved by WHO-listed national regulatory authorities, and which are recommended by WHO's Strategic Advisory Group of Experts on Immunization, or SAGE.

I have triggered the process for Emergency Use Listing of both vaccines, which will accelerate vaccine access particularly for lower-income countries, which have not yet issued their own national regulatory approval. Emergency Use Listing also enables partners including Gavi and UNICEF to procure vaccines for distribution.

WHO is grateful to Japan, the United States, the European Union and manufacturers for working with us on **vaccine donations**. We are working with all partners through the interim Medical Countermeasures Network to facilitate equitable access to vaccines, therapeutics, diagnostics and other tools.

In light of the spread of Mpox outside DRC, and the potential for further international spread within and outside Africa, I have decided to convene an Emergency Committee under the International Health Regulations to advise me on whether the outbreak represents a public health emergency of international concern.

The committee will meet as soon as possible and will be made up of independent experts from a range of relevant disciplines from around the world.

Good morning, good afternoon and good evening,

Today the WHO family is in mourning over the sudden passing of our dear friend and colleague, Aidan O'Leary, the Director of the WHO Polio Eradication Programme. Aidan died suddenly last night from natural causes while on holiday with his family.

He was an outstanding humanitarian who served tirelessly in the most difficult parts of the world. He joined WHO in 2020, after a career of service in the United Nations in some of the world's most difficult places, including Afghanistan, Gaza, Iraq, Syria, Pakistan and Yemen. He embodied the ideal of service and solidarity across peoples and borders.

His passing is a terrible loss for WHO and for all of humanity, but most of all for his family and friends, in his native Ireland and throughout the world. On behalf of WHO, I extend my deepest condolences to them all.

We will miss Aidan enormously, and we will remember him for his kindness, openness and friendliness. He was a gentle giant, in every sense.

We are committed to continuing his legacy to realise his vision - and ours - of a polio-free world...

One of the last things Aidan was working on was preparations for two rounds of polio vaccination campaigns in Gaza, targeting 600 000 children under the age of 8. WHO is sending more than 1 million polio vaccines to Gaza, which will be administered in the coming weeks.

The detection of polio in wastewater in Gaza is a tell-tale sign that the virus has been circulating in the community, putting unvaccinated children at risk. **WHO** is also supporting routine immunization and disease surveillance, including for polio.

We need absolute freedom of movement for health workers and medical equipment to carry out these complex operations safely and effectively.

A ceasefire, or at least "days of tranquility" during preparation and delivery of the vaccination campaigns are required to protect children in Gaza from polio...

Transcript

COVID-19 update

Dr. Maria Van Kerkhove, Director of Epidemic and Pandemic Preparedness & Prevention at the World Health Organization (WHO), stressed that **COVID-19 was still very much with us and was circulating in all countries**. Data from WHO's sentinel-based surveillance system across 84 countries reported that the percent of positive tests for SARS-CoV-2 had been rising for several weeks. **Overall, test positivity was above 10 percent, but this fluctuated per region.**

In Europe, for example, percent positivity was above 20 percent. In recent months, regardless of the season, many countries had experienced surges, including at the **Olympics, where at least 40 athletes had been tested positive**. Governments needed to continue to invest and support a global understanding of circulation and impact and provide their populations with the tools to protect themselves and care for people suffering from acute and long-term effects of COVID-19, including post COVID-19 condition.

Regular and robust risk assessments, improved ventilation, and high vaccination coverage were among recommendations to governments around the world, said Dr. Van Kerkhove. Countries were urged to share more genetic sequences and regularly report data on hospitalizations, ICU admissions, and deaths. WHO urged more financial support to study post-COVID long term conditions.

Finally, as individuals, we all needed to take steps to reduce the risk of infection. Billions of COVID-19 vaccines had been administered around the world, preventing millions of deaths. The highest-risk groups should receive their new COVID-19 vaccines within 12 months of their last dose, said Dr. Van Kerkhove. Governments ought to secure adequate supplies of both COVID-19 and influenza vaccines, ahead of the cold season in the northern hemisphere, stressed Dr. Van Kerkhove.

Responding to questions from the media, Dr. Van Kerkhove said that at the Olympics in Paris, the authorities, in cooperation with the WHO, had taken a number of measures to prevent spread of infectious diseases. More people than before were wearing masks at the Olympic Games. The levels of COVID-19 impact were different now, compared to 2020-2022.

Governments need to make sure that their at-risk populations were vaccinated at least once in 12 months; those vaccines should be given along with influenza vaccines. The critical question was when the last dose had been administered, especially for people over 60 and vulnerable groups.

Dr. Van Kerkhove said that the WHO looked at trends from month to month. Hospitalization rates had increased in the Americas, Europe, and the Pacific; **only 35 countries or territories were providing relevant information with the WHO.**

The true toll of COVID-19 deaths was still unknown. Some six percent of all COVID-19 cases had gone on to develop post-COVID symptoms, which meant many millions of people were now suffering from long COVID. Vaccines needed to be made available to populations, especially those at risk. Regarding the availability of vaccines, there was clearly a decrease in demand, but the virus was not gone, said Dr. Van Kerkhove. There was a large section of the population that required vaccines on a regular basis, so there could be no talk that there was no "market" for the vaccines. WHO could not put COVID-19 on the back burner as much as we might wish to do so personally...

Decades of research have shown that the most disadvantaged communities exist at the intersection of high levels of hazard exposure, racial and ethnic marginalization, and poverty.

Mapping and geographical information systems have been crucial for analyzing the environmental burdens of marginalized communities, and several federal and state geospatial tools have emerged to help address environmental justice concerns — such as the Climate and Economic Justice Screening Tool developed in 2022 in response to Justice40 initiatives from the Biden administration.

Standards in Medical-Legal Partnerships

Complex demands of patients' socially, culturally, and politically situated health needs have given rise to what have become known as medical-legal partnerships (MLPs). An MLP is a model of US-based health and legal service provision that generally looks to offer combined, single-site interprofessional responses to patients whose health status and access to health services can be compromised by their need for legal help. Patients who are immigrants, were recently incarcerated, or lack reliable and safe shelter or employment, for example, can experience health vulnerabilities that call for legal expertise, perhaps in the form of advice; aid in petitioning a court or program; referral; representation in administrative proceedings; or advocacy. This theme issue investigates strategies by which clinicians and attorneys should work together to screen for and ably respond with care to legal determinants of patients' health.

Despite an increased recognition of the right of adolescents to be involved in decisions that affect them, young people continue to be under-involved in health research. One of the reasons is a lack of awareness among researchers on the current evidence base around the benefits of involving adolescents. To address this, we conducted an umbrella review to synthesize the evidence on the positive impacts of adolescent involvement in health research. This umbrella review was preregistered with PROSPERO (CRD42021287467). We searched 11 databases, Google Scholar, PROSPERO, reference lists, 10 journals, websites of 472 organizations, and sought input from experts. Ultimately, we included 99 review articles. We found that adolescent involvement has many positive impacts on young people, including increased knowledge and skills; personal development; financial benefits; career and academic growth; enhanced relationships; and valuing their experience. The positive impacts of adolescent involvement on the research itself include increased relevance of the study to adolescents, improved recruitment, development of more adolescent-friendly materials, enhanced data collection and analysis, and more effective dissemination. Researchers also benefited from adolescents' involvement through increased knowledge, skills, and a shift in their attitudes. The evidence supporting the positive impacts of adolescent involvement in research is substantial but limited by a lack of rigorous evaluation, inconsistent reporting, and unclear evaluation methods.

Pathology in the era of generative AI

Precise and swift pathology is a major pillar in the detection, diagnosis, and treatment of a broad range of conditions, such as cancer, infectious diseases, and autoimmune disorders. It is an essential approach to preventive medicine, effective treatment planning, and identifying new diagnostic markers of diseases. Computational pathology, which involves computer-based methods to analyse and interpret pathological image data, has seen substantial evolution due to advancements in artificial intelligence (AI)-assisted methods, widespread adoption of digital pathology slides, and increased availability of pathology image datasets. As we see groundbreaking applications of large language models (LLM) and generative AI, what is the effect of these technologies on digital pathology?

In this issue of The Lancet Digital Health, <u>Omar and colleagues</u> discuss the potential of LLMs like OpenAI's ChatGPT-4 in the field of medical research, particularly digital pathology, highlighting the need for domain-specific AI tools, given the limited precision of generalist LLMs in this area. Omar and colleagues also present the <u>Digital Pathology Assistant</u>, a toolkit for computational pathology aiming to simplify the processing and analysis of pathology imaging data using the PathML library, capable of handling large-scale pathology imaging datasets.

Building on these advancements, Lu and colleagues described the <u>PathChat</u>, a new multimodal generative AI, that combines three key components: the vision encoder, the multimodal projector module and the LLM, representing a major leap forward in human pathology. PathChat outperforms other tools based on the commercially available state-of-the-art LLMs, providing high-quality answers to diagnostic questions from diverse tissue origins and disease models related to pathology. Importantly, the code used to train PathChat is publicly accessible for non-commercial academic purposes.

<u>Li and colleagues</u> further validate the practical applications of these technologies by examining the Cpath TIL-score biomarker, which is based on the density of tumour infiltrating lymphocytes (TIL), to evaluate its association with recurrence risk and the benefit of adjuvant treatment in whole slide images of ductal carcinoma in situ (DCIS) from a large randomised controlled trial cohort. The study found that high TIL density in patients with DCIS significantly increases the risk of ipsilateral breast events (IBE) and invasive IBE, but also indicates a greater benefit from radiotherapy, highlighting its prognostic and predictive value.

Although the potential of AI in digital pathology is substantial, it is essential to address its numerous limitations and ethical considerations. Challenges such as the interpretability of AI models and integration of these models into current workflows need careful navigation. Moreover, the quality and generalisability of AI tools might be compromised by biases inherent in the datasets used for their training. Under-representation of minority demographic groups is a real concern. Hence, evaluating how varying demographic compositions in training and testing cohorts impact the performance of AI models is crucial, yet often overlooked.

The potential of such AI tools is particularly relevant when considering health inequity concerns related to access to care, especially in low-income and middle-income countries (LMICs) where a notable increase in cancer cases is estimated to result in nearly 75% of all cancer fatalities by 2030. Hence, it is crucial to prioritise strategies that promote the development and implementation of digital pathology in LMICs. Potential strategies include provision of open pathology datasets, development of open-source models, establishment of public-private partnerships, and strategic and long-term funding research projects. These projects should focus on implementation science initiatives, the development of innovative technologies, collaborative research efforts led by local researchers and clinicians to adapt these technologies to local contexts.
