# <u>Second meeting of the International Health Regulations (2005) Emergency Committee</u> <u>regarding the upsurge of mpox 2024</u>

28 November 2024 Statement

The Director-General of the World Health Organization (WHO) is hereby transmitting the report of the second meeting of the International Health Regulations (2005) (IHR) Emergency Committee (Committee) regarding the upsurge of mpox 2024, held on Friday 22 November 2024, from 12:00 to 17:00 CET.

Notwithstanding some progress towards controlling the spread of mpox resulting from national and international response efforts, **the Committee noted the rising number and continuing geographic spread of mpox cases**, especially those due to monkeypox virus clade Ib infection; the operational challenges in the field in need of stronger national commitments; as well as the need to mount and sustain a cohesive response across countries and partners.

The Committee advised that the event continues to meet the criteria of a public health emergency of international concern (PHEIC) and provided its views regarding the proposed temporary recommendations.

The WHO Director-General expresses his most sincere gratitude to the Chair, Members, and Advisors of the Committee. **The WHO Director-General concurs with the advice of the Committee that the event continues to constitute a PHEIC** for the reasons detailed in the proceedings of the meeting below, and issues revised temporary recommendations in relation to this PHEIC, which are presented at the end of this document.

#### ...Conclusion

The Committee reiterated its concern regarding the continuing spread of MPXV and uncertainties ensuing, and the effectiveness and efficiency of the response at the local level. The Committee underscored the need for the sustained commitment by national authorities in focusing efforts and resources at the local level to interrupt MPXV transmission, as well as the role of coordinated international cooperation in supporting and complementing such efforts in a synergistic manner. Therefore, the Committee considers that the determination by the WHO Director-General that the upsurge of mpox still constitutes a PHEIC would be warranted.

#### Headlines

- New data published in *Vaccines* scientific journal this week shows significantly reduced risk of variant type 2 poliovirus (cVDPV2) emergence from novel oral polio vaccine type 2 (nOPV2), compared with monovalent oral polio vaccine type 2 (mOPV2). The research evaluated data from OPV2 vaccination campaigns held between May 2016 to August 2024, and findings are consistent with accumulated clinical and field evidence of nOPV2's enhanced genetic stability. <a href="More">More</a>.
- The Global Certification Commission for the Eradication of Poliomyelitis (GCC) convened in Geneva, Switzerland, last week, to review latest global epidemiology, new action plans including of the currently-being-developed Global Polio Surveillance Action Plan (GPSAP), planning for bivalent OPV cessation, containment and post-certification, and received a brief on the GPEI Strategy extension. #### **WORLD AIDS DAY REPORT 2024 – TAKE THE** *RIGHTS* **PATHTO END AIDS**

The world now has the means to end AIDS as a public health threat by 2030.

#### INTRODUCTION

The world's decades-long response to HIV is at an inflection point. The 2024 Joint United Nations Programme on HIV/AIDS (UNAIDS) global report, The Urgency of Now: AIDS at a Crossroads, demonstrated that the world now has the means to end AIDS as a public health threat by 2030 (1).

Midway to the 2025 milestone set at the United Nations General Assembly in June 2021, the global HIV response has moved closer to the goal of ending AIDS as a public health threat by 2030, a commitment enshrined in the Sustainable Development Goals (SDGs). Fewer people acquired HIV in 2023 than at any point since the late 1980s. Almost 31 million people were receiving lifesaving antiretroviral therapy in 2023, a public health success that has reduced the numbers of AIDS-related deaths to their lowest level since the peak in 2004.

Despite these successes, the world is currently not on track to end AIDS as a public health threat by 2030. In 2023, 9.3 million [7.4 million–10.8 million] people living with HIV were still not receiving antiretroviral therapy and 1.3 million [1.0 million–1.7 million] people newly acquired HIV.

In the regions where numbers of new HIV infections are growing the fastest, only very slow progress is being made in scaling up pre-exposure prophylaxis (PrEP). These regions also lag behind sub-Saharan Africa in progress towards meeting the 95–95–95 HIV testing and treatment targets. Coverage of prevention services among the populations at greatest risk of HIV is far too low— typically at less than 50%. In at least 28 countries, the number of new HIV infections is on the rise, and a growing resource gap imperils the important progress made to date in the global HIV response.

At this historic crossroads, the path the world takes—towards ending AIDS, or towards a future of needless illness, death and unending costs—depends on political will.

# The central role of human rights in the global HIV response

Many people consider the creation of UNAIDS in 1996 as marking a starting point for the modern global HIV response. Recognizing that efforts to address the HIV pandemic needed to extend well beyond the health sector, HIV stakeholders purposely established a multisectoral United Nations joint programme to galvanize actions at the global, regional and country levels to respond to HIV and AIDS, which at the time was increasing exponentially and erasing decades of development gains, but receiving only limited attention.

Community and civil society organizations led the way in demanding that the international community ground the response to HIV in human rights principles. Placing people and human rights at the centre of the global HIV response was, therefore, a defining principle of UNAIDS from its outset. As one of its very first steps, in 1996 UNAIDS joined with the Office of the United Nations High Commissioner for Human Rights to develop the International Guidelines on HIV/AIDS and Human Rights. Following consultations with international experts on health and human rights, the International Guidelines were amended in 2002 and consolidated in 2006 (4).

At a time when many countries and stakeholders were uncertain as to how best to address a spiralling health challenge, the International Guidelines provided a roadmap for aligning national responses with human rights commitments. The International Guidelines advised: "Public health interests do not conflict with human rights. On the contrary, it has been recognized that when human rights are protected, fewer people [acquire HIV] and those living with HIV and their families can better cope with HIV and AIDS" (4).

Human rights have continued to guide and inspire the global HIV response—from the global movement for universal access to affordable HIV treatment, to focused efforts to remove punitive laws targeting people living with HIV, women and girls, and people from key populations, to the 10–10–10 social enabler targets for 2025.

GENEVA, 26 November 2024— Ahead of World AIDS Day (1 December), a <u>new report by UNAIDS</u> shows that the world can meet the agreed goal of ending AIDS as a public health threat by 2030 – but only if leaders protect the human rights of everyone living with and at risk of HIV. The report's message is summed up in its title: "Take the rights path to end AIDS".

"Despite huge progress made in the HIV response, human rights violations are still preventing the world from ending AIDS," said Winnie Byanyima, Executive Director of UNAIDS. "When girls are denied education; when there is impunity for gender-based violence; when people can be arrested for who they are, or who they love; when a visit to health services is dangerous for people because of the community they are from—the result is that people are blocked from being able to access HIV services that are essential to save their lives and to end the AIDS pandemic. To protect everyone's health, we need to protect everyone's rights."...

The <u>report</u> includes ten guest essays from leaders in the global AIDS response including: Elton John; Archbishop of Cape Town, Thabo Makgoba; Irish President, Michael D. Higgins; United Nations High Commissioner for Human Rights, Volker Türk; and former President of the International AIDS Society, Adeeba Kamarulzaman.

Elton John, in his essay in the UNAIDS report, writes, "I know the feeling of shame and what it can do. As long as HIV is seen as a disease for the 'others', not so-called 'decent people', AIDS will not be beaten. Science, medicine and technology may be the 'what' in ending AIDS, but inclusion, empathy and compassion are the 'how'."

President Michael D. Higgins, in his essay, writes, "Ensuring that the fullness of human rights is achieved is a practical necessity crucial if we are to rid the world of the scourge of AIDS. Fulfilling the pledge to end AIDS as a public health threat is a political and financial choice. The time to choose the correct path is long overdue."...

# **World Trade Organisation – Vaccine Classification**

<u>Members endorse thematic sessions workplan, welcome progress on vaccine classification</u> 20 November 2024

At a meeting of the Committee on Market Access (CMA) on 19-20 November, members agreed to wrap up a series of thematic sessions on supply chain resilience. **They also welcomed progress on a joint effort by the World Customs Organization (WCO), World Health Organization (WHO) and the WTO to establish new tariff headings for vaccines**, a move which will help facilitate the implementation of relevant trade and public health policies. Members also addressed a high number of trade concerns...

# WHO-WCO-WTO proposal for new HS codes on vaccines

The Committee heard a report from the World Customs Organization (WCO) about recent developments at the latest sessions of the WCO's <u>Harmonized System Committee</u> (HSC) and Review Sub-Committee (RSC) relating to the Committee's communication on the classification of COVID-19 essential goods. The report noted the Committee's interest in making the HS classification more granular in respect of vaccines.

Currently, there is only one subheading for "vaccines for human medicine", under which all vaccines traded today are classified. This has complicated the adoption of targeted trade policy

measures and the collection of international trade statistics, particularly during the COVID-19 pandemic.

The HS Review Sub-Committee continued the examination of a revised proposal from the World Health Organization, which was developed in collaboration with the WTO and the WCO secretariats, to streamline the number of new subheadings that are being proposed to cover all major disease groups for which vaccination is important. According to the proposal, a new heading 3007, "vaccines for human medicine", will be created in HS 2028, under which seven new positions are included. This will include several HS subheadings naming a total of 36 vaccines against specific diseases...

The interim Chairperson said she agreed that the collaboration among the WCO, WHO and WTO was instrumental in achieving the approval of the vaccine proposal and represented a tangible outcome. Improving the granularity of vaccines in the next version of the HS will render their trade flow more transparent and will facilitate the implementation of trade but also public health policies, she said. This will contribute among other things to a more effective response in future global health crises, she added.

#### Global report on infection prevention and control 2024

Overview

Health care-associated infections (HAIs) affect patients and health systems every day, causing immense suffering, driving higher health-care costs and hampering efforts to achieve high-quality care for all. HAIs are often difficult to treat, are the major driver of antimicrobial resistance (AMR) and cause premature deaths and disability. The COVID-19 pandemic, as well as outbreaks of Ebola, Marburg and mpox are the most dramatic demonstrations of how pathogens can spread rapidly and be amplified in health care settings. But HAIs are a daily threat in every hospital and clinic, not only during epidemics and pandemics. Lack of water, sanitation and hygiene (WASH) in health care settings not only affects

the application of infection prevention and control (IPC) best practices but also equity and dignity among both those providing and receiving care. However, there is strong evidence that a large proportion of these infections could be prevented with IPC measures and basic WASH services, with a high return on investment. This second global report on IPC provides updated evidence on the harm caused to patients and health workers by HAIs and AMR, and presents an updated global analysis of the implementation of IPC programmes at the national and health care facility levels across all WHO regions

**Abstract** 

Vaccination timeliness is often not considered among standard performance indicators of routine vaccination programmes, such as vaccination coverage, yet quantifying vaccination delay could inform policies to promote in-time vaccination and help design vaccination schedules. Here, we analysed vaccination timeliness for 24 routine childhood immunisations for 54 countries. We extracted individual vaccination status and timing from Demographic and Health Surveys data from 54 countries with surveys from 2010 onwards. Individual data was used to estimate age at vaccination for <5 year-old children. Recommended age of vaccination for each country and vaccine was compared to the age at vaccination to determine vaccination delay. The evolution of vaccination delay over time was described using estimates from different birth cohorts. To identify socio-demographic indicators associated with delayed vaccination, we used multivariable Cox regression models with country as random effect and estimated the Hazard Ratio for vaccination with each vaccine-dose for each week post recommended vaccination age. Vaccine coverage at the recommended age was highest for birth and first doses (e.g. 50.5% BCG, 18.5% DTP-D1) and lowest for later doses (e.g. 5.5% DTP-D3, 16.3% MCV-D1, 8.2% MCV-D2). Median delay was lowest for birth doses, e.g. BCG (1 week (IQR: 0 to 4)), and it increased with later doses in vaccination courses: 1 (0, 4) week for DTP-D1 versus 4 (2, 9) weeks for DTP-D3. Although the median delay for each vaccine-dose remained largely constant over time, the range of delay estimates moderately decreased. Children living in rural areas, their countries' poorer wealth quintiles and whose mothers had no formal education were more likely to received delayed vaccinations. Although we report most children are vaccinated within the recommended age window, we found little reduction on routine immunisation delays over the last decade and that children from deprived socioeconomic backgrounds are more likely to receive delayed vaccinations.

# Number of interventional clinical trials registered per million population per country worldwide

Background Historically, Sweden and Denmark have excelled in clinical trial publications per million population, but many trials have remained unpublished. Enforceable policies for trial registration before launch, made global and national clinical research assessments possible. The World Health Organisation (WHO) hosts the International Clinical Trials Registry Platform (ICTRP) for interventional clinical trials, with data from 1999.

Objective To find out if the retrospective or prospective trial registration activities per million population per country during the 2009 to 2022 period have improved after establishing the number of interventional clinical trials registered per million population per country during the 1999 to 2022 period.

Methods We used the WHO ICTRP to extract the numbers of registered interventional clinical trials. We entered data in Microsoft Excel to analyse two separate periods, 1999 to 2022 and 2009 to 2022. The second period aimed at filtering out the pickup of the registration requirements. To obtain the trial registration activity by country, we divided the number of interventional clinical trials registered by the country's population in millions. Information on population numbers originated from the World Bank, the Central Intelligence Agency World Factbook, and The National Institute of Statistics and Economic Studies (of France) as of 2022. We collected data as of 03-01-2024.

Results In February 2023, there were 943.113 interventional clinical trials on the ICTRP. After excluding 32.309 trials with unknown country of origin, 910.804 trials from 229 countries and territories were analysed. For countries or territories with populations over 1 million, the top five in interventional clinical trial registrations per million during 1999-2022 were Denmark, Estonia, Belgium, The

Netherlands, and Latvia. For 2009-2022, they were Denmark, Estonia, Belgium, The Netherlands, and New Zealand. The top five overall, irrespective of population, for both periods were Pitcairn, The Vatican, Tokelau, Niue, and Denmark.

Conclusions Since 1999, there has been worldwide growth in interventional trial registrations, especially among top-contributing countries. The global average stands at approximately 115 registered trials per million people from 1999 to 2022, highlighting the need for continued efforts to improve trial registration and production. Smaller Western countries lead in interventional clinical trials per million population.
