Pandemic Accord

World Health Assembly adopts historic Pandemic Agreement to make the world more equitable and safer from future pandemics

20 May 2025 *News release*

- Agreement's adoption follows three years of intensive negotiation launched due to gaps and inequities identified in national and global COVID-19 response.
- Agreement boosts global collaboration to ensure stronger, more equitable response to future pandemics.
- **Next steps include negotiations on Pathogen Access and Benefits Sharing system.**

Member States of the World Health Organization (WHO) today formally adopted by consensus the world's first Pandemic Agreement. The landmark decision by the 78th World Health Assembly culminates more than three years of intensive negotiations launched by governments in response to the devastating impacts of the COVID-19 pandemic, and driven by the goal of making the world safer from – and more equitable in response to – future pandemics.

"The world is safer today thanks to the leadership, collaboration and commitment of our Member States to adopt the historic WHO Pandemic Agreement," said Dr Tedros Adhanom Ghebreyesus, WHO Director-General. **"The Agreement is a victory for public health, science and multilateral action.** It will ensure we, collectively, can better protect the world from future pandemic threats. It is also a recognition by the international community that our citizens, societies and economies must not be left vulnerable to again suffer losses like those endured during COVID-19."

Governments adopted the WHO Pandemic Agreement today in a plenary session of the World Health Assembly, WHO's peak decision-making body. **The adoption followed yesterday's approval of the Agreement by vote (124 in favour, 0 objections, 11 abstentions) in Committee** by Member State delegations...

The WHO Pandemic Agreement sets out the principles, approaches and tools for better international coordination across a range of areas, in order to strengthen the global health architecture for pandemic prevention, preparedness and response. This **includes through the equitable and timely access to vaccines, therapeutics and diagnostics.**

Regarding national sovereignty, the Agreement states that: "Nothing in the WHO Pandemic Agreement shall be interpreted as providing the Secretariat of the World Health Organization, including the Director-General of the World Health Organization, any authority to direct, order, alter or otherwise prescribe the national and/or domestic law, as appropriate, or policies of any Party, or to mandate or otherwise impose any requirements that Parties take specific actions, such as ban or accept travellers, impose vaccination mandates or therapeutic or diagnostic measures or implement lockdowns."

Notes for editors

The resolution on the WHO Pandemic Agreement adopted by the World Health Assembly sets out steps to prepare for the accord's implementation. **It includes launching a process to draft and negotiate a Pathogen Access and Benefit Sharing system (PABS) through an Intergovernmental Working Group (IGWG). The result of this process will be considered at next year's World Health Assembly.**

Once the Assembly adopts the PABS annex, the WHO Pandemic Agreement will then be open for signature and consideration of ratification, including by national legislative bodies. After 60 ratifications, the Agreement will enter into force.

In addition, Member States also directed the IGWG to initiate steps to enable **setting up of the Coordinating Financial Mechanism** for pandemic prevention, preparedness and response, **and the Global Supply Chain and Logistics Network (GSCL)** to "enhance, facilitate, and work to remove barriers and ensure equitable, timely, rapid, safe, and affordable access to pandemic-related health products for countries in need during public health emergencies of international concern, including pandemic emergencies, and for prevention of such emergencies."

According to the Agreement, pharmaceutical manufacturers participating in the PABS system will play a key role in equitable and timely access to pandemic-related health products by making available to WHO "rapid access targeting 20% of their real time production of safe, quality and effective vaccines, therapeutics, and diagnostics for the pathogen causing the pandemic emergency." The distribution of these products to countries will be carried out on the basis of public health risk and need, with particular attention to the needs of developing countries.

The WHO Pandemic Agreement is the second international legal agreement negotiated under Article 19 of the WHO Constitution, the first being the WHO Framework Convention on Tobacco Control, which was adopted in 2003 and entered into force in 2005.

European Vaccines Hub (EVH) for Pandemic Readiness

[Launch of the European Vaccines Hub for Pandemic Readiness, a new European public-private partnership for public health-relevant vaccine development](#)

The Health Emergency Preparedness and Response Authority (HERA) of the European Commission, through the European Health and Digital Executive Agency (HaDEA) supports the establishment of the "European Vaccines Hub (EVH) for Pandemic Readiness", a pan-European center dedicated to advancing public-health-relevant vaccine development. The Grant Agreement has been signed today, marking a transformative step in public-health-relevant vaccine development.

By integrating excellence in vaccine research, human monoclonal antibody (H-mAbs) development, clinical trials, and scalable manufacturing activities, EVH creates a dynamic and collaborative European environment.

The EVH consortium is made up of 11 Beneficiaries, 13 Affiliated and Associated entities, from 7 different countries, including leading EU organizations directly involved in vaccine development and in charge of pandemic preparedness in their own countries. **The EVH project is coordinated by the "Sclavo Vaccines Association"**, a non-profit organization based in Siena devoted to support vaccine research and development.

The EVH project contributes to the development of an agreed set of pandemic-prototype vaccines and scalable technologies through a consortium of major EU Vaccine R&D institutions and manufacturers, ensuring effective coordination of national vaccine research programs. EVH aligns with the current international consensus on pandemic-vaccine development, leveraging insights from existing prototypes to enable the rapid selection and deployment of the most suitable vaccine candidates in an emerging pandemic.

Structured around four pillars supporting key activities and infrastructures of the vaccine development pipeline, EVH integrates leading European institutions with distinct expertise and in charge of pandemic preparedness in their own countries. In detail:

- Pillar 1 on "Discovery" is led by Fondazione Biotechnopolo di Siena (Italy),
- Pillar 2 on "Preclinical studies" by Institut Pasteur (France),
- Pillar 3 on "Clinical studies" by Vaccinopolis (UAntwerpen, Belgium), and
- Pillar 4 on "Manufacturing" by DZIF and ZEPAI (Germany).

EVH aims thus not only to create a reactive R&D system and knowledge hub linking powerful leading research institutions, but also initiate vaccine-development projects, refining relevant processes and procedures within its framework. The focus is on a select group of pathogens deemed critical for pandemic preparedness, as identified in the recently issued WHO Pathogens Prioritization report for the

European region. From prototype design to clinical applications, the EVH drives innovation, enhance clinical evaluation capacities, and coordinate efforts with manufacturers while optimizing the digitalization of vaccine design and distribution processes.

"The EVH represents a transformative initiative to strengthen Europe's ability to respond to future health emergencies," said Rino Rappuoli, Scientific Director of Fondazione Biotecnopolo di Siena. "By uniting top vaccine developers, Biotechs and academia cross Europe, we aim to drive innovation and ensure strategic autonomy in vaccine R&D and manufacturing."

Global Animal Health

First report on world's animal health reveals changing spread of disease impacting food security, trade and ecosystems - OIE

Inaugural State of the World's Animal Health report finds several animal diseases reaching new areas, with half of those reported able to jump to people.

Key findings:

- Animal diseases are migrating into previously unaffected areas, half (47%) of which have zoonotic – or animal-to-human – potential.
- Outbreaks of bird flu in mammals more than doubled last year compared to 2023, increasing the risk of further spread and human transmission.
- Access to livestock vaccines remains uneven around the world, with disease eradication efforts facing funding and political challenges.
- Antibiotic use in animals fell by 5% between 2020 and 2022 and expanding livestock vaccination globally would reduce the risk of antibiotic resistance.

23 May, PARIS – Infectious animal diseases are affecting new areas and species, undermining global food security, human health and biodiversity, according to the first State of the World's Animal Health report.

The new annual assessment, published by the World Organisation for Animal Health (WOAH), provides the first comprehensive review of animal disease trends, risks and challenges, from the uptake and availability of vaccines to the use of antibiotics in animals. Released ahead of WOAH's 92nd General Session and its Animal Health Forum – where leading experts will gather to discuss vaccination and innovation in disease prevention – the report sets the stage for high-level discussions on how science-based vaccination strategies and emerging technologies can help address current and future animal health threats through a One Health approach.

Among its findings, the report revealed the reported number of avian influenza outbreaks in mammals more than doubled last year compared to 2023 with 1,022 outbreaks across 55 countries compared to 459 outbreaks in 2023.

The authors highlighted that, while the risk of human infection remains low, the more mammalian species such as cattle, cats or dogs infected, the greater the possibility of the virus adapting to mammal-to-mammal, and potentially human, transmission.

"The spread, prevalence and impact of infectious animal diseases is changing, bringing new challenges for agriculture and food security, human health and development, and natural ecosystems," said Dr. Emmanuelle Soubeyran, Director General of WOAH...

The Assembly of the International Council for Harmonisation (ICH) met in-person on 13 & 14 May, in Madrid, Spain in parallel of meetings of 11 Working Groups preceded by meetings of the ICH Management Committee and the MedDRA Management Committee.

New Areas of ICH Harmonisation

The Assembly adopted four new topics for harmonisation at the Madrid meeting, with the starting timeframe to be determined in a subsequent step:

- "Considerations for the Use of Real-World Evidence (RWE) to Inform Regulatory Decision Making with a focus on Effectiveness of Medicines" – a new ICH Efficacy Guideline that proposes a systematic approach to using RWE in regulatory decision making;
- "Framework for Determining Utility of Comparative Efficacy Studies in Biosimilar Development Programs" – a new ICH Multidisciplinary Guideline to address factors to consider in determining the utility of comparative efficacy studies (CES) in biosimilar development programs;
- "Natural History Studies and Registry Data to Advance Rare Disease Drug Development" – a new ICH Efficacy Guideline aims to provide high-level, harmonised principles for designing and conducting natural history studies and registries in rare diseases;
- "Comparability of Advanced Therapy Medicinal Products (ATMPs) Subject to Changes in Their Manufacturing Process (Annex to ICH Q5E)" – A new Annex to the ICH Multidisciplinary Guideline ICH Q5E is proposed to address the unique development and regulatory challenges of ATMPs, such as gene and cell therapies.

Global leaders convene to accelerate access to long-acting HIV prevention technologies amidst funding cuts

23 May 2025

On the eve of the 78 World Health Assembly, global health leaders, government ministers, pharmaceutical companies, and civil society representatives gathered at UNAIDS headquarters in Geneva for the High-Level Multisectoral Leadership Dialogue on HIV Prevention. This High-Level dialogue, organized by the Global HIV Prevention Coalition and co-hosted by UNAIDS in collaboration with UNFPA, WHO, and UNDP, the Federal Republic of Brazil, and the Kingdom of the Netherlands, focused on accelerating access to long-acting HIV prevention technologies and advancing sustainable prevention systems.

Referring to the current funding crisis, Winnie Byanyima, Executive Director of UNAIDS, warned that "If we continue down this path, we could see an additional 6 million HIV infections and 4 million AIDS-related deaths by 2029. Put simply, we will lose control of the AIDS pandemic. But we have an opportunity today. We have new, long-acting HIV prevention tools that could fundamentally reshape the HIV response, putting us back on the right path."

Global leaders presented successful national models from Africa, Asia and Latin America, illustrating how innovative prevention strategies are being implemented despite financial challenges. Mariangela Simao, representing Brazil, said "PrEP in Brazil is now a reality. We initially set a target of reaching 50,000 people with PrEP by 2025, but we've already surpassed that milestone, with 122,000 people

currently using it. Our next goal is to reach 300,000 users by next year. Data shows that HIV incidence is declining in cities with more than 100,000 inhabitants where PrEP coverage is higher.”..

WASHINGTON, D.C. (May 22, 2025) – Pharmaceutical Research and Manufacturers of America (PhRMA) president and CEO Stephen J. Uhl issued the following statement on today's Make America Healthy Again (MAHA) Commission report:

"The administration is right to focus on understanding the root causes of chronic disease in children, including food, environmental toxins and other lifestyle factors. But when people get sick, they should have every option available to them to get better – including medicines. Medicines are part of the solution, not the cause of chronic disease. That's why our industry wakes up every day focused on developing new treatments to fight and prevent disease."

The report made several untrue or misleading claims. As you cover the report, please keep in mind:

- **“Overmedicalization”:** The biopharmaceutical industry believes decisions about childhood medication should always be made with the guidance of doctors and parents’ involvement and as part of a comprehensive treatment plan customized to fit each person's unique needs and condition.
- **Vaccine value:** Other than clean water, arguably nothing has done more to improve public health than vaccines – which have eliminated dangerous diseases like polio and smallpox in the U.S. It’s essential for public health and U.S. pandemic preparedness that we maintain a policy environment that supports continued advances in vaccines.
- **Vaccine clinical trials & safety:** Vaccines are held to extremely high safety standards. Because vaccines are given to healthy people starting at birth, they are typically studied for years in large-scale clinical trials involving thousands of volunteers to ensure both safety and effectiveness. FDA approval relies on rigorous randomized, controlled studies with an appropriate comparator – which may be a placebo when no other vaccine is available or approved. When there is an existing vaccine, for ethical reasons, studies are designed to compare a new vaccine to an existing vaccine to avoid exposing participants to unnecessary risks.

The EsoBiotec Engineered NanoBody Lentiviral (ENaBL) platform empowers the immune system to attack cancers and could offer many more patients access to transformative cell therapy treatments delivered in just minutes rather than the current process which takes weeks.

ENaBL uses highly targeted lentiviruses to deliver genetic instructions to specific immune cells, such as T cells, which programme them to recognise and destroy tumour cells for cancer treatment or autoreactive cells for potential use in immune-mediated diseases. This approach enables cell therapies to be administered through a simple IV injection and without the need for immune cell depletion.

As a result of this acquisition, EsoBiotec has become a wholly owned subsidiary of AstraZeneca, with operations in Belgium

One way private equity differs from other for-profit investments is by aiming to maximize profitability while minimizing long-term holdings in such investments. Artificial intelligence (AI) has recently seen transformative breakthroughs in the life sciences, expanding possibilities for researchers to interpret biological information at an unprecedented capacity, with novel applications and advances being made almost daily. In order to maximise return on the growing investments in AI-based life science research and accelerate this progress, it has become urgent to address the exacerbation of long-standing research challenges arising from the rapid adoption of AI methods. We review the increased erosion of trust in AI research outputs, driven by the issues of poor reusability and reproducibility, and highlight their consequent impact on environmental sustainability. Furthermore, we discuss the fragmented components of the AI ecosystem and lack of guiding pathways to best support Open and Sustainable AI (OSAI) model development. In response, this perspective introduces a practical set of OSAI recommendations directly mapped to over 300 components of the AI ecosystem. Our work connects researchers with relevant AI resources, facilitating the implementation of sustainable, reusable and transparent AI. Built upon life science community consensus and aligned to existing efforts, the outputs of this perspective are designed to aid the future development of policy and structured pathways for guiding AI implementation.
